# Accessibility statement for mobile compliance of TU Online VLE

This statement is for the TU Online virtual learning environment accessed from <a href="http://tuonline.tees.ac.uk">http://tuonline.tees.ac.uk</a>.

This system is device agnostic and can be assessed seamlessly via desktop PC, tablets and other handheld devices include mobile phones.

The system consists of the commercial D2L Brightspace platform, third-party plugins and module content. This website is run by Teesside University.

We want as many people as possible to be able to use this website. For example, that means you should be able to:

- · change colours, contrast levels and fonts
- zoom in up to 400% without the text spilling off the screen
- navigate the website using just a keyboard
- navigate the website using speech recognition software
- listen to the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver)

AbilityNet has advice on making your device easier to use if you have a disability.

#### How accessible this website is

D2L Brightspace, our platform provider has published a public accessibility statement at https://www.d2l.com/accessibility where a full accessibility compliance checklist is available through the VPAT (Voluntary Product Accessibility Template) and WCAG (Web Content Accessibility Checklist) 2.0 AA checklists.

The D2L Platform also allows users to customise their experience through D2L Account Settings.

#### This includes:

- Choosing font size
- Users can disable the opening of secondary windows and include such content in the main page
- Users can turn off rich text features for easier navigation with assistive technologies
- Users of an assistive technology such as a screen reader can disable the tool
  that automatically denotes learning content has been read. This ensures that
  navigation using the screen reader does not flag as completion.
- A setting to ensure that assistive technologies can detect videos within the platform.
- Key design principles of the content in each module area will allow you to
- use assistive technologies including screen readers such as JAWS and VoiceOver.
- Navigate through the platform using only the keyboard.
- The first option in every page is to skip to the main page content.

- Tab through content in a logical order
- Change colours, contrast levels and fonts using in-browser tools
- Text reflows in a single column when you change the size of the browser window
- Video content is accompanied by a transcript

#### **Panopto auto-captions**

We use Panopto to create and share recorded learning materials and lectures. Panopto provides captions through automated speech recognition (ASR) a technology that is not 100% accurate. To mitigate the fact that captions will not be 100% accurate, we have provided guidance for staff on how to optimise the quality of captions in their recordings.
